David is the founder and Chairman of the Portcullis Group of companies which in late 2004 acquired the TrustNet Group. The Portcullis Group and the TrustNet Group have merged to form one of the biggest independent groups of trust companies in Asia with offices in Singapore, Hong Kong, Taipei, Samoa, Cook Islands, British Virgin Islands, Kuala Lumpur and Labuan (Malaysia), Mauritius and Seychelles.



David Chong was a lecturer in the National University of Singapore (NUS) for 3 years. He has a Master's Degree in Law and a Master's Degree in Business. He is the Senior Partner of the law firm, David Chong & Co. He is qualified as a Barrister of England, as an Advocate & Solicitor of Singapore, Malaya, Brunei, as a Solicitor in Australia and as Barrister & Solicitor of the British Virgin Islands.

David was the first President of Society of Trust & Estate Practitioners (STEP) (Singapore Chapter); and is the President of STEP (Malaysia Chapter). David is also a member of the Board of Governors of the NUS High School of Math & Science and also a member of the Board of Governors of United World College of South East Asia.
